

# About Medicare Part D

"Extra Help," or a Low-Income Subsidy (LIS), May Be Available for Your Medicare Patients<sup>1</sup>

### What is Medicare Part D?

The Medicare Prescription Drug Program, or "Part D," offers prescription drug coverage to all Medicare beneficiaries. To obtain coverage, individuals enroll in either a stand-alone Prescription Drug Plan (PDP) or a Medicare Advantage PDP, administered by an insurance company approved by Medicare.<sup>2</sup>

### How much do patients pay under Part D?

The Centers for Medicare & Medicaid Services (CMS) sets a defined standard benefit each year, but plans are permitted to offer coverage (basic or enhanced) that is actuarially equivalent to this benefit. Nearly all plans opt to offer actuarially equivalent coverage, meaning that plans vary in terms of cost and drugs covered. The standard benefits design consists of a monthly premium, a yearly deductible, copayments or coinsurance, and catastrophic coverage. Additionally, Medicare Part D categorizes drugs into tiers, each with different costs; lower-tier drugs are generally less expensive than higher-tier ones.<sup>23</sup>

### How can Medicare patients get "Extra Help" with paying for their drugs?

Some patients with LIS, such as those who are dually eligible for Medicare and Medicaid, are deemed eligible, whereas others must apply. Enrollees with low incomes and modest assets who have not been automatically assigned to a plan can **contact the Social Security Administration (SSA) or their State Medicaid Agency** to determine whether they qualify. Examples of how subsidies can help are shown on the next page.<sup>23</sup>

### LIS eligibility and cost sharing<sup>5</sup>

The 2024 federal poverty level (FPL) guidelines determine the income-level requirements for people applying for the Medicare Part D LIS program, also known as the *Extra Help program*.

- » The amount of Extra Help a beneficiary receives depends on his or her income and resources
- » Beneficiaries will receive either a full subsidy or a partial subsidy

### Part D: Typical Costs for Beneficiaries Receiving LIS (Extra Help)<sup>a</sup>

Medicare beneficiaries whose income is ≤135% of FPL (with asset levels valued at no more than \$9,090 for singles and \$13,630 for couples) and who may receive the full LIS benefit	No copayment above out-of-pocket threshold	
Medicare beneficiaries whose income is <150% of FPL (with asset levels valued at no more than \$15,160 for singles and \$30,240 for couples) and who may receive partial LIS benefits	• 15% coinsurance up to the out-of-pocket threshold of \$8,000 and then \$11.20 copayment for a brand-name drug

#### Once an individual has been approved, receiving the LIS subsidy is fairly quick and easy. Patients will receive a notification explaining that they're approved and what their reduced copay will be<sup>2</sup>
